1.0 About the AAU

The Association of African Universi es (AAU) was established in November 1967 as the initiative of African higher education leaders, with the cardinal function of coordinating and networking Higher Education Institutions (HEIs) at the continental level and providing leadership in developing and promo ng a common vision for African higher education. The Association with its headquarters in Accra, Ghana has grown from the initial membership of 34 public universi es to now 450 member HEIs from 48 countries across Africa, Asia, Europe, and North America.

The AAU is the only HEI association with a continent-wide scope that embraces all forms of disciplinary orientation. Its broad-based nature, inclusiveness and capacity have made AAU the main advocate for and convener of all stakeholders on general Higher Education (HE) matters in Africa. AAU commissions strategic research to generate evidence for advocacy and inform continental higher education policies and practices and serves as the intelligence arm of HE in Africa. Given the experience, expertise and scope of operation, the African Union Commission (AUC) has entrusted AAU with the coordination of the Higher Educa on Cluster of the Continental Educa on Strategy for Africa (CESA 16-25).



Professor Olusola Oyewole is the Secretary-General of the Association of African Universities (AAU) based in Accra, Ghana. He holds the position of Professor of Food Science and Technology, specializing in Food Microbiology and Biotechnology, at the Federal University of Agriculture, Abeokuta, Nigeria, where he is currently on sabbatical leave. Previously, he served as Vice Chancellor of the University from May 2012 to May 2017. With over thirty-six years of experience in African higher education, Professor Oyewole has authored over one hundred scholarly publications. His career spans significant roles such as Senior Expert at the African Union Commission in Ethiopia, focusing on Quality Assurance, Mobility, and Scholarships. He also coordinated the British Government-sponsored project at AAU, promoting regional initiatives for higher education revitalization from 2007 to 2009. Professor Oyewole's contributions extend to international platforms, including his role as Project Officer for the World Bank's "Quality Assurance for African Higher Education Systems" from 2006 to 2009. He has a strong background in coordinating multinational research and development programs and advocating for research funding. At the African Union, he oversees the Mwalimu Nyerere Scheme, encompassing initiatives like the African Quality Rating Mechanisms (AQRM), Mwalimu Nyerere Scholarship program, and the African-EU-ACP Mobility scheme. He currently serves on the Advisory Group of the OECD Programme on Innovation, Higher Education, and Research for Development, and as sub-cluster coordinator for the African Union Commission's Continental Education Strategy for Africa (CESA) on Research and Graduate Professor Olusola Oyewole's professional interests include quality assurance, leadership, and management in African higher education systems, as well as research system development.

She is Zimbabwe's representative on the African Vice Chancellors' Forum, a member of the International Association of Universities board, representing Africa, a member of the Zimbabwe Council for Higher Educa on (ZIMCHE) council, a board member of the Centre for Zimbabwean Studies at Rhodes University, a board member for the Forum for African Women Educationalists Zimbabwe (FAWEZI), a member of the SAFAIDS regional advisory group, a gender equality expert for the African Group of Negotiators, a think tank of experts and practitioners that provides evidence based technical support to African governments for effective engagement in the international and national climate change policy formula on; She is a focal person for Zimbabwe for the Resilient Africa Network (RAN), a USAID funded project working with over 100 Universi es in East, West and Southern Africa; she is a focal person for Zimbabwe for the USAID Funded Long-term Assistance and Services for Research (Laser) Partner University Led Solutions Engine (PULSE) working with Purdue University, Makerere University and Catholic Relief Services. She has won several awards for her outstanding performance as an educationalist and administrator.

The AAU has established regional offices to widen its reach and enhance its impact across Africa. Mrs Gono has spearheaded the establishment of the governance structures for the AAU SARO Office to be all inclusive in tackling regional higher education issues. She provides secretariat services to the AAU SARO Board.

Mrs Gono was the Director for Marketing, Communications & Public Relations of the University since June 2017 to November 2023. She was the custodian of the WUA Brand. Her roles included media liaison, marketing, events management and 2 coordination, exhibitions, publications and digital marketing. She also coordinated Alumni activities and Community

Engagement. The tasks which enhanced the university brand by increasing visibility and awareness. In this role, she played a critical part in information dissemination and business continuity during the Covid 19 Pandemic.

From May 2012 to May 2017, Mrs Gono was the University's Director for Resource Mobilisation and Marketing. She was responsible for growing the University partners and enrolment. She was also branding custodian and media liaison.

In January 2012, Mrs Gono was appointed a member of the International Association of Universities (IAU) Reference Group on Higher Education focusing on Education for All (EFA) and Achievement of the Millennium Development Goals (MDGs) by 2015 for the period 2012 to 2015 as an Advisor, information sharing and recognition of EFA related activities undertaken by institutions of higher learning. contributed in the 3 development and establishment of the Early Childhood Development Model Centers in the University to cater for female students and surrounding communities as well as practical

She has been nominated for various business accolades and awarded the Megafest 2014 Top 20 Outstanding Women in Business.

She was the designate Officer for Zimbabwe Broadcasting Holdings in the African Broadcast Media Partnership (ABMP) Against HIV/AIDs. She managed coordinate the National selections for the Imagine Afrika reality show for 2007 where the Zimbabwe candidate was on the winning group which scooped US\$6000 each. The 2008 reality show, on the same programme, managed to have three Zimbabweans being in the top 30 of Africa select. This programme profiled young African Achievers matching their ingenuity and leadership in tackling challenges confronting many poor communities across Africa such as HIV/AIDs, water & sanitation, training

and food supply. The show focused on themes including gender equality and equity, open communication about gender roles,

HIV/AIDs, stigma and HIV-testing. The campaign emphasised on personal action and urged all Africans to consider their role in realizing an HIV free generation under the tag line 'Imagine the possibility of HIV-free generation: It begins with You.'

In her portfolio of community engagement at the Women's University in Africa, she succeeded in bringing key research collaborations with the University College of London (UCL) on a project titled: Mapping risk and resilience to mental health consequences of child marriage in Zimbabwe. She also brought in the University of West England (UWE) collaboration in the delivery of the module titled Professional Practice in Change Leadership at post graduate level.

Mrs Gono has coordinated a lot of events that have impacted positively in the women empowerment agenda. These included public lecture series that focused on issues affecting women and children covering issues of gender-based violence, child marriages, human trafficking, and African Union agenda 2063 among others.

Mrs Gono was a volunteer of the 18 th ICASA (International Conference on AIDS and STIs in Africa Zimbabwe 2015).

WUA PROFILE

WUA is a private institution that was co-founded by two visionaries, Professor Hope Cynthia Sadza a former Public Service Commissioner, and Dr Fay King Chung the former Minister of Education in Zimbabwe. The institution was established through a Trust Deed MA692/2001 and granted authority to operate as a university by the Parliament of Zimbabwe through Statutory Instrument 130 of 2004. The University governance structures are provided for in the Trust Deed and the Charter. The Charter provides for a three-tier governance structure comprising the Board of Trustees (BoT), Council and Senate.

The University's main campus is located in Marondera town, 80km southeast of Harare. The University is currently operating from five campuses in Zimbabwe, namely the Harare campus, in Manresa Park, the Bulawayo campus at Charter House, the Kadoma campus, the Mutare campus and Marondera campus along Pine Street and at the Helianth Farm.

The University opened its doors to the public in 2002 with 145 students with a specific mandate to address gender disparity and foster equity in university education. Currently, the University has 5,583 students. Since its first graduation ceremony in 2005, the University has churned out 16 079 graduates of which 12 848 are females and 3 249 are males.

WUA focuses on problem of women's access to university education. Its enrolment policy of 85% women and 15% men is contributing towards the 50:50 gender participation ratio enunciated in the SADC Protocol on Gender and Development and the Constitution of Zimbabwe. The University currently has three Faculties namely: Agricultural, Environmental and Health Sciences; Management and Entrepreneurial Sciences; and Social and Gender Transformative Sciences. WUA offers a flexible study timetable consisting of the blended approach to learning with online and face to-face teaching and learning adopted as a preventive measure against COVID-19 and regular day, weekend, block release and Open Distance Learning (ODL). WUA has students from other African countries and efforts are underway to increase enrolment of students from the SADC region through the University's ODL Programme.
